Dr Madeleine Gray is Head of History at the University of Wales, Newport, and an editor of the Gwent County History. Her book, *Images of Piety*, on the iconography of late medieval religion in Wales, was published by BAR in 2000, and she is now working on a study of the rewriting and re-visioning of medieval saints' cults.

Mae **Dr Christine James** yn Uwch-Ddarlithydd ac yn Bennaeth Adran y Gymraeg, Prifysgol Cymru, Abertawe. Mae hi'n awdurdod ar lenyddiaeth Gymraeg yr Oesoedd Canol diweddar a'r Cyfnod Modern Cynnar, ac yn ymddiddori'n arbennig yn hanes llenyddol Morgannwg. Yn 2001 golygodd *Cerddi Gwenallt: Y Casgliad Cyflawn*, ac enillodd Goron yr Eisteddfod Genedlaethol yn 2005.

Dr Sally Harper is Senior Lecturer in the School of Music at University of Wales, Bangor. Her publications include *Music in Welsh Culture before 1650: a study of the principal sources* (Aldershot, 2007) and *Medieval English Benedictine Liturgy: Studies in the Formation, Structure and Content of the Monastic Votive Office, c. 950-1540* (London, 1993). She is the co-editor with Wyn Thomas of *Cynheiliaid y Gân / Bearers of Song* (University of Wales Press, 2007), and the editor of the bilingual journal, *Hanes Cerddoriaeth Cymru / Welsh Music History*.

Prys Morgan, the President of the Honourable Society, is Professor Emeritus of Welsh History, University of Wales Swansea. His publications include *A History of the University of Wales, vol. 3, 1939-1993* (Cardiff, 1997), and (as editor), *Brad y Llyfrau Gleision: ysgrifâu ar hanes Cymru* (1991).

Professor Sioned Davies is Head of the School of Welsh at the University of Cardiff. She is an authority on the Mabinogion and has published ground-breaking studies on the narrative techniques of the *cyfarwydd* (storyteller) and the complex relationship between literacy, orality and aurality in medieval Wales. Her most recent publication is a new translation of the eleven tales of *The Mabinogion* (World Classics series, Oxford University Press, 2007). She is presently engaged on a research project on the dramatic preaching of nineteenth- and twentieth-century Wales.

Cyn-Athro'r Gymraeg ym Mhrifysgol Cymru, Abertawe, yw **Hywel Teifi Edwards**. Cymru oes Victoria yw prif faes ei lafur academaidd ac y mae wedi cyhoeddi nifer o gyfrolau ac erthyglau ar ddiwylliant y cyfnod hwnnw, gan roi sylw arbennig i'r Eisteddfod Genedlaethol fel sefydliad allweddol. Ar hyn o bryd y mae'n ysgrifennu cyfrol Saesneg ar 'The Cardiff National Pageant of Wales, 1909' ar gyfer ei chyhoeddi gan Wasg Gomer.

Dr Margaret Escott is a Senior Researcher with the History of Parliament Trust. Her publications include contributions on the history of parliamentary representation to *Cardiganshire County History*, vol. 3, and *Gwent County History*, vol. 4. She is currently editing a collection of 'Swing Riots' papers for Berkshire Record Society.

Professor Neil McIntyre, FRCP, was educated at Porth County School for Boys, and King's College London. He was Professor of Medicine, Royal Free Hospital School of Medicine, 1978-99. A specialist in clinical hepatology, his publications include *Lipids and Lipoproteins in Clinical Practice* (1991). He is presently President of the History of Medicine Society of Wales.

Dr Anne Price-Owen is Senior Lecturer in the Faculty of Art, Design and Media, Swansea Institute, University of Wales. She has written extensively on the visual arts and poetry, including *David Jones: Diversity in Unity: Studies in his Literary and Visual Art*, edited with Belinda Humfrey (2000). In 1996 she inaugurated the David Jones Society, with R.S.Thomas as the first Honorary President.

Richard Gwynedd Parry is a barrister of Gray's Inn and Senior Lecturer in Law at the University of Wales, Swansea. He has published widely on aspects of criminal justice in the leading law journals, and is also interested in the legal history of Wales.

Lord Morris of Aberavon, KG, QC, LLD, was MP for Aberavon, 1959-99, Secretary of State for Wales, 1974-79, and Attorney General, 1997-99. He is the Chancellor of the University of Glamorgan and an Honorary Fellow of the University of Wales, Aberystwyth, of Gonville and Caius College, Cambridge, and of the Academy of International Law, The Hague. He has been Lord Lieutenant of Dyfed since 2002, and became a life peer in 2001 and a Knight of the Garter in 2003.

Emeritus Professor Geraint Gruffydd, a past Honorary Editor of the *Transactions*, was formerly the Librarian of the National Library of Wales and was the first Director of the University of Wales Centre for Advanced Welsh and Celtic Studies.

Professor Emeritus Harold Carter is a former Head of the Department of Geography at University of Wales, Aberystwyth.

The Council wishes to thank those who accepted its invitation to deliver lectures and for the quality of their contributions to the programme. Thanks are extended also to those who chaired the meetings. Attendance at all the meetings was very good. We would also like to extend our thanks to the staff of the British Academy who have accommodated our meetings. We should also acknowledge the help and facilities provided at the National Eisteddfod.

The *Transactions* for 2005 were published in 2006. The Council wishes to thank all the contributors and put on record its appreciation of the work undertaken by the Honorary Editor and the Honorary Publications Officer.

The Council is grateful to those members who represented it on various public bodies in Wales during the course of the year.

In 2006 the Society began to actively develop a publicity and marketing strategy increase membership and enhance publicity for its activities. We should like to thank those members who have given their time to this initiative which we hope will bear fruit from 2007.

Membership of the Society stands at 902.

Work proceeds apace on the *Dictionary of Welsh Biography* and Council is very grateful to members who are undertaking the burden of preparation and publication.

The process of digitizing the *Transactions* is to be undertaken by the National Library of Wales and further information on this will be available in 2007.

Several events relating to Welsh issues took place in London during 2006 and members of the Society were present. Of particular note was the gathering at the House of Commons supporting plans place a commemorative plaque to Iolo Morganwg in north London; and also an event seeking support from Welsh people in London in the launch of the proposed Welsh daily newspaper *Y Byd*.

It was, of course, a bitter blow that Professor Emrys Jones died after a brief illness in the summer of 2006. The Council wishes to record its sadness and sends its condolences to Professor Jones's family. A bald sentence in an annual report cannot do justice to his immense contribution to Wales and to academic life and a tribute to him will appear in the next issue of the *Transactions*.

At the end of 2006, John Samuel retired as Hon. Secretary after fifteen years of stalwart service to the Society in that capacity. We are all thankful, particularly the new Secretary, that he is not severing his links with the Society completely.

At the Annual General Meeting of 2006, Professor Prys Morgan was re-elected President on the motion of Peter Jeffreys and seconded by Jenkin Thomas. All current Vice-Presidents were re-elected. Dr Gwenda Thompson was also elected a Vice-President of the Society.

On the motion of Gwenda Sippings, seconded by Ken Kyffin, Anne Arnold, Stuart Cole, Elinor Delaney, David Hilling, Arwyn Lloyd Hughes, Peter Jeffreys, David Owen-Jones, Ceridwen Roberts and Peter Roberst were elected for a period of three years. Professor Neil McIntyre was elected for a period of one year and Jon Parry was elected for a period of two years.

Dr Gwenda Thompson retired from Council after a period of 35 years.

On the motion of Douglas Brooks, seconded by Jon Parry, E Glyn Hughes was re-appointed as Auditor for the forthcoming year.
