Thanks are also extended to those who chaired the meetings. Attendance at most of the meetings was very good. We would also like to extend our thanks to the staff of the British Academy who have accommodated our meetings. We should also acknowledge the help provided at the National Eisteddfod.

The *Transactions* for 2007 was published in 2008. The Council wishes to thank all the contributors and put on record the work undertaken by the Honorary Editors and the Honorary Publications Officer. It is a fine volume and many readers have praised the contents.

The Council is grateful to all those members who represented the Society on various public bodies in Wales during the course of the year.

Individual and institutional membership stands at just over 800; as invoices were late being dispatched this resulted in many falling outside the financial year. The continuing marketing of the Society is beginning to show fruit. It has been pleasing to see new faces at all the lectures in the course of the year. However, quite a few members have passed away in the course of the year and some have chosen not to re-enrol. This was particularly so in the case of institutional members.

Work proceeds apace on the *Dictionary of Welsh Biography* and the Council is very grateful to Dr Brynley F Roberts for his labours during the course of the year.

Dr Peter Roberts has now fully relinquished his position as Editor of the Society's *Transactions* having acted as joint editor with Professor Helen

Fulton for a transition year in 2008. Dr Roberts has brought the highest levels of scholarship to bear on the *Transactions* and made them an essential and accessible publication for both scholar and layperson alike. We are deeply grateful for his immense work in enriching both the Society and the culture of Wales.

At the Annual General Meeting for 2008 Professor Prys Morgan was re-elected President and all current Vice-Presidents were re-elected.

The following Council members were re-elected for a period of three years: Douglas Brooks, Professor Stuart Cole, Professor T Charles Edwards, Professor John Elliott, Dr Rhidian Griffiths, Jon Parry, Professor Brynley Roberts, David J Watkins.
