Cyhoeddwyd *Trafodion 2009* yn 2010. Dymuna'r Cyngor ddiolch i'r holl gyfranwyr ac i nodi llafur y Golygydd Mygedol a'r Swyddog Cyhoeddiadau Mygedol. Mae'r gwaith o ddiigidoli'r Trafodion yn parhau.

Mae'r Cyngor yn ddyledus i'r aelodau a fu'n gynrychiolwyr y Gymdeithas yn ystod y flwyddyn ar amryw o gyrff cyhoeddus yng Nghymru.

Yn dilyn y penderfyniad i greu Pwyllgor Cyllid ac yn sgîl goruchwyliaeth gadarn o'r cyllid, mae'n dda cael adrodd bod golwg raenus ar iechyd cyllidol y Gymdeithas ac yn nhermau y cyfrifon ym 2010, mae'r Gymdeithas yn gweithredu gyda gweddill. Mae'r cynllun tair-blynedd a oedd yn cynnwys dadansoddiad o dreuliau'r Gymdeithas ac asesiad o danysgrifiadau'r aelodau, wedi creu sefydlogrwydd a dyfodol cadarn i'r Gymdeithas. Ym 2011 mae'r sefyllfa gadarnhaol yma wedi galluogu'r Gymdeithas i fuddsoddi mewn gwefan newydd, cynnyrch cyhoeddi a logo newydd. Dymuna'r Gymdeithas ddiolch i'r Athro Stuart Cole am ei gyfraniad helaeth wrth weithredu'n unol a'r Trysorydd Mygedol, i sicrhau'r canlyniad yma. Mae'r Pwyllgor Cyllid bellach, wedi trosglwyddo'r awenau, o ran gweithgareddau ac aelodaeth, yn ôl i'r Ysgrifennydd Mygedol a'r Ysgrifennydd Aelodaeth.

Am rai blynyddoedd mae'r Gymdeithas wedi cadw swyddfa a stôr yn Eglwys Castle Street a disgwylir cynilion pellach o ganlyniad ymadael a'r ystafell. Penderfynwyd ar y cam yma gan nad oedd y swyddfa o werth ymarferol bellach ac hefyd am fod gan y corff newydd, Eglwys Unedig Canol Llundain, gynlluniau i ddefnyddio'r ystafell. Trosglwyddwyd rhan helaeth o archif y Gymdeithas yn ddigost, i Lyfigell Genedlaethol Cymru, Aberystwyth, lle y caiff ei didoli a'i chatalogio. Penderfynwyd rhoi'r gweddill mewn stordy archifol, nes gwneud y penderfyniad gorau ynghylch storio'r papurau, yn enwedig o ystyried posibiliadau

digidol. Gwagiwyd yr ystafelloedd yn East Castle Street ddechrau Rhagfyr 2010 a dymuna'r Gymdeithas roi ar gof eu diolch i ddiaciaoniaid y capel am ei cydweithrediad i sicrhau hwylustod y symud ac am eu cymorth a'u cefnogaeth dros y blynyddoedd y bu'r Gymdeithas yn cyd-gartrefu a nhw.

Mae gan y Gymdeithas ychydig dros bedwar can aelod ond disgwylir gwell adnabyddiaeth o aelodau a chasgliad hwylusach o'r tanysgrifiadau, gyda datblygiad a chynhaliath effeithiol y gronfa-ddata newydd. Estynnwn ddiolch i Adrian Morgan am ei waith yn cofnodi yr aelodaeth a chreu rhestrau dibynnol. Wrth gydnabod yr arwyddocâd o gynnal gwefan effeithiol yn codi ymwybyddiaeth o'r Gymdeithas ac yn denu aelodau newydd, mae'r Cyngor yn dal i geisio canfod adnoddau i wireddu hyn, a disgwylir adroddiad gan weithgor bach sut y gellir gwneud newidiadau cyn gynted ag sy'n bosibl.

Bydd cyflwyno sianelau newydd o gyfathrebu yn galluogi cysylltiadau cryfach gyda'r aelodaeth, agwedd a anogir ar bob elusen. Wrth ateb y gofynion yma, mae'r Gymdeithas wedi ceisio rhoi sylw i'r cyfrifoldebau a ddiffinir gan y Ddeddf Elusenu 2006 a chan Siarter Brenhinol y Gymdeithas ac i ba raddau y bydd angen gwneud newidiadau i'w gweithrediad a'i dulliau trefnu. Fel rhan o'r broses yma penderfynwyd lleihau maint y Cyngor, fel y bo aelodau yn ymddeol, er mwyn cyfyngu nifer y Cyngor i ddeunaw a thrwy hynny, lleihau y nifer o Ymddiriedolwyr; ymgynnull pwyllgor bach gweithredol i drafod busnes pwysig o frys; cyflwyno trefniadau newydd, ym 2012, yn ymwneud a threfnu'r cyfarfod cyffredinol blynyddol. Fe hoffai'r Cyngor weld mwy o aelodau, nid o anghenraid aelodau'r Cyngor, yn ymwneud ag is-bwyllgorau a gweithgorau, tebyg i'r un sy'n ystyried y rhaglen.

Yn ystod y flwyddyn daeth gwybodaeth i law oddi wrth y Trysorydd Mygedol, Cecil Roberts, yr hoffai ymddeol fel y Trysorydd cyn gynted ag y medrid dod o hyd i olynydd iddo, er ei fod yn hapus i aros fel aelod o'r Cyngor. Mae'n dda gan y Cyngor gyhoeddi fod Huw Wynne-Griffith wedi cytuno ymgymeryd a'r swydd a bod ef a Cecil Roberts wedi cytuno ar amserlen i drosglwyddo'r awenau a'r cyfrifoldebau. Hoffai'r Cyngor ddiolch yn daer i Cecil Roberts am y cyfraniad sylweddol a wnaeth yn tywys cyllid y Gymdeithas am flynyddoedd lawer ac yn enwedig yn ystod yr anawsterau diweddar.

Tristwch o'r mwyaf i'r Cyngor oedd y newyddion am farwolaeth y Dr. Geraint James, y meddyg adnabyddus ac un o Is-Lwyddion y Gymdeithas, ym mis Hydref 2010. Bu'n aelod o'r Cyngor ac yn gymwynaswr hael am flynyddoedd lawer. Tristwch mawr hefyd, oedd cofnodi marwolaethau yr Is-Lwyddion Canon Allchin, Rachel Bromwich a'r Athro Eric Sunderland ac hefyd David Watkins, cyn-aelod selog o'r Cyngor.

The Council wishes to thank both those who accepted its invitation to deliver lectures and those who chaired the meetings. The quality of these contributions to the programme has been acknowledged while attendance at most meetings was good. The Council would wish to thank the staff of the Royal Society of Engineering in whose premises all the London lectures were held, the officers and staff of the Welsh Assembly for their help in providing lecture space in Tŷ Hywel in Cardiff and assistance provided at the National Eisteddfod.

The *Transactions* for 2009 was published in 2010. The Council wishes to thank all the contributors and to put on record the work undertaken by the Honorary Editor and the Honorary Publications Officer. Work on the digitization of the *Transactions* has continued.

The Council is grateful to all those members who represented the Society on the various public bodies in Wales during the course of the year.

Following the decision taken to establish a Finance Committee and a regime of greater financial rigour, it is pleasing to report that the financial health of the Society has improved and that, in terms of the accounts for 2010, the Society is now operating in surplus. The three-year financial plan, which included an analysis of the Society's expenses and an assessment of membership fees, has resulted in greater stability and provides for the financial future of the Society and this positive position has enabled the Society to plan for investment in 2011 in a new web site, new print production and logo. The Council would wish to thank Professor Stuart Cole for his considerable contribution in working with the Society's treasurers to achieve this position. The Finance Committee has now passed back its role in events and membership management to the Secretary and to the Membership Secretary respectively.

Further efficiencies are anticipated as a result of the decision to vacate the premises in East Castle Street in which the Society has maintained a small office and storage facilities for many years. This decision was taken both in acknowledgement of the fact that the facilities were of less practical value than in previous years and that our landlords, Eglwys Unedig Canol Llundain, themselves had plans to

reconfigure the premises to meet their own changing needs. The greater part of the Society's archive has been transferred, at no cost, to the National Library of Wales, Aberystwyth where it will be collated and catalogued, while the remainder has been lodged in an archive retrieval store until such time as a decision is taken on how best, particularly in a digital age, material should be stored. The premises in East Castle Street were evacuated at the beginning of December 2010 and the Society would wish to place on record its thanks to the deacons of the Chapel both for their cooperation in helping to effect a smooth removal and for their help and support over the many years in which the Society has been in occupation.

The Society has currently just over four hundred paid-up members but it is anticipated that with the development and effective maintenance of an accurate database of members, there will be greater efficiency in the identification of members and in the collection of subscriptions. Thanks are extended to Adrian Morgan for his work in putting membership records on a more reliable basis. The Council, in acknowledging the significance of an effective web site in raising the profile of the Society and in helping to recruit members, has continued to identify resources to make this possible and is awaiting the report of a small working group on how quickly changes can be implemented.

The introduction of more effective channels of communication will also enable the Council to maintain stronger links with the membership as a whole, an aspect which all charities are encouraged to address. In responding to this need, the Council has recently been giving attention to its responsibilities as defined by the Charities Act 2006 and by its Royal Charter, and to the extent to which it might require to make adjustments to its practices and procedures. As part of this process it has decided to reduce, as and when members retire from office, the size of the Council to eighteen – thereby reducing the number of trustees – to set up a small executive group to consider urgent business, and to introduce new arrangements, in 2012, relating to the organisation of the annual general meeting. It would also like to see a greater involvement by members, not necessarily members of the Council, in the deliberations of groups such as the one that considers the programme of events.

During the course of the year the Honorary Treasurer, Cecil Roberts, intimated that while happy to remain a member of Council, he would wish to step down as Treasurer as soon as a successor could be identified. The Council is pleased to report that Huw Wynne-Griffith has agreed to take over and that he and his predecessor have agreed a timetable for the transfer of responsibilities. The Council would wish to thank Cecil Roberts for the considerable contribution he has made in guiding the Society's finances over many years and, recently, in times of difficulty.

The Council was saddened to hear of the death in October 2010 of Dr Geraint James, the eminent physician and a Vice-President of the Society. For many years he was a member of the Council and a generous benefactor. We were equally sorry to receive news of the deaths of Canon Allchin, Rachel Bromwich and Professor Eric Sunderland, all Vice-Presidents, and of David Watkins, a long standing member of Council.

At the Annual General Meeting for 2010 Professor Prys Morgan was re-elected President and all current Vice-Presidents were re-elected.

The following Council members were elected for a period of three years: Clive Jones-Davies, Rhian Davies, Ken Kyffin, Adrian Morgan, D Ben Rees, Cecil Roberts, Jenkin Thomas, Gwenda Sippings

During the year Huw Wynne Griffith was co-opted to serve as a member of the Council.

Accounting Records

The trustees are also responsible for safeguarding the charity's assets and hence for taking reasonable steps for the prevention and detection of error, fraud and other irregularities.

In preparing the accounts the trustees are expected to select suitable accounting policies and apply them consistently, making judgements and estimates that are reasonable and prudent.
