## LLYFRAU A DDERBYNIWYD / BOOKS RECEIVED

# Sean Davies, *The First Prince of Wales? Bleddyn ap Cynfyn, 1063–75.* Cardiff: University of Wales Press, 2016

The first biography of Bleddyn ap Cynfyn, one of the independent princes of early medieval Wales, the book argues that Bleddyn should be regarded not simply as a regional prince of the Powys dynasty but as a major player in Welsh power politics at the time of the Norman Conquest of 1066. Inheriting a kingdom that comprised most of the regions of Wales brought together by his predecessor and half-brother Gruffudd ap Llywelyn, Bleddyn supported the Anglo-Saxon earls in their resistance to the Normans. This is a scholarly but very readable story about a significant Welsh ruler whose leadership provides a new perspective on the Norman Conquest.

# Rhian E. Jones, *Petticoat Heroes: Gender, Culture and Popular Protest in the Rebecca Riots.* Cardiff: University of Wales Presss, 2015

The 'Rebecca riots' took place in west Wales between 1839 and 1843 as a form of protest against the tolls charged by landowners and businessmen to use the roads. In her study of these events, Rhian Jones focuses on the female costumes worn by the rioters, mostly farmers and farm workers, and the symbolism of the biblical figure of Rebecca as the figurehead of the riots. The book considers ways in which the image of Rebecca was used in Victorian cultural and political discourse, especially in the popular press of the time.

Michael Powell Siddons, *Welsh Genealogies A.D. 1500–1600*. Aberystwyth: CMCS Publications, 2015

This is a continuation of Peter Bartrum's monumental study of medieval Welsh pedigrees, most of it now online. In this volume, Michael Siddons, the distinguished historian and genealogist, adds more than two hundred new family lines which began in Wales in the sixteenth century. This printed volume comes with a CD and the two are designed to be used together to trace family trees from Tudor Wales.

## Steph Davies, Hiraeth: Stories from Welsh Patagonia. Parthian Books, 2015.

Published to coincide with the 150<sup>th</sup> anniversary of the founding of the Welsh colony in Patagonia in 1865, this collection of interviews and real-life stories told by descendants of the first colonists captures the drama of the first settlement and the challenges faced by Welsh Patagonians then and now.

Mae'r Cyngor yn ddiolchgar i'r rhai a dderbyniodd y gwahoddiad i ddarlithio – yn enwedig yr Is-Gadfridog Jonathon Riley a Dr Adam Chapman, y ddau wedi camu i'r bwlch ar fyr rybudd – ac i'r rhai a gadeiriodd y cyfarfodydd. Mae diolch y Cyngor yn fawr hefyd i Gymdeithas Feddygol Llundain ble cynhaliwyd pob un ond un o ddarlithoedd Llundain a Swyddfa Llywodraeth Cymru yn Heol Fictoria a ddarparodd y lleoliad ar gyfer y ddarlith Gymraeg flynyddol. Mae'r Cyngor yn ddiolchgar hefyd am y cymorth a gafwyd yn yr Eisteddfod Genedlaethol ym Meifod.

Roedd nifer dda wedi mynychu'r darlithoedd trwy gydol y flwyddyn. Roedd y cyfraniadau i'r rhaglen o ansawdd uchel ac yn ysgogi diddordeb sylweddol yn y gynulleidfa, fel y gwelwyd yn y sesiynau gofyn ac ateb bywiog a'r trafodaethau a ddilynodd y darlithoedd.

## Cyhoeddiadau a gwybodaeth ar-lein

Mae dosbarthu gwybodaeth yn elfen allweddol o waith y Gymdeithas. Gwna hyn yn bennaf trwy gyhoeddi'r cylchgrawn, y *Trafodion*, a thrwy'r wefan a ail-ddatblygwyd yn ddiweddar.

## Trafodion y Gymdeithas

Cyhoeddwyd Cyfrol 20 (2014) yng Nghyfres Newydd y *Trafodion* yn ystod y flwyddyn ac anfonwyd copi i bob un o aelodau unigol a chorfforaethol y Gymdeithas yn y Deyrnas Unedig a thramor. Mae'r Cyngor yn diolch i'r holl gyfranwyr ac yn cofnodi ei werthfawrogiad o'r gwaith a wnaed gan y Golygydd Mygedol a'r Bwrdd Golygyddol.

Ceisia'r Gymdeithas, ble bo hynny'n bosibl, i gyhoeddi testun y darlithoedd yn y cylchgrawn ar gyfer y flwyddyn berthnasol. Nid yw hyn yn bosibl bob tro – er engraifft, nid yw rhai siaradwyr yn dymuno neu ddim yn gallu (oherwydd materion hawlfraint) cyhoeddi eu papurau neu oherwydd ei bod yn anodd i drosglwyddo darlithoedd gyda chynnwys gweledol sylweddol i erthyglau ysgrifenedig. Cytunwyd yn ystod 2015 y byddai'r Golygydd a'r Ysgrifennydd Mygedol yn archwilio ffyrdd y gellid argyhoeddi'r siaradwyr o'r gwerth i'r Gymdeithas o gyhoeddi eu darlithoedd yn y *Trafodion* yn fwy eglur nag o'r blaen. Disgwylir y bydd hyn yn golygu canran uwch o ddarlithoedd yn cael eu cyhoeddi yn y blynyddoedd i ddod.

Cytunodd y Cyngor, yn amodol ar waharddiad dwy flynedd o ryddhau deunydd ac ar unrhyw gyfyngiadau a ellid eu gorfodi oherwydd hawl awduron unigol i ymarfer hawlfraint a pherchnogaeth, y dylai cyfrol gyfan pob cyhoeddiad o'r *Trafodion* fod ar gael i'r cyhoedd ar ffurf ddigidol, trwy borth Llyfrgell Genedlaethol Cymru, *Cylchgronau Cymreig Ar-lein*. (Ystyria'r Cyngor pe bai'r cyhoeddiadau presennol ar gael yn rhwydd byddai llai o anogaeth i gael copïau caled trwy aelodaeth o'r Gymdeithas ac y byddai hyn yn gallu cael effaith negyddol ar recriwtio.)

#### Darparu gwybodaeth ar-lein

Yn unol â'i ymrwymiad i wella cyfathrebu ac i ddwyn gweithgareddau'r Gymdeithas i sylw'r cyhoedd yn ehangach, yn ystod 2014 cytunodd y Cyngor i gomisiynu gwefan â ffrâm gwifren (http://www.cymmrodorion.org/), am £8,000. Mae'r gwaith wedi ei gwblhau ac mae'r cynnyrch gorffenedig yn darparu golwg mwy ffresh a modern gyda mwy o allu i ddiweddaru deunydd. Defnyddir y wefan i hysbysebu digwyddiadau'r Gymdeithas ac i roi cyhoeddusrwydd i weithgareddau eraill. Yn ystod y flwyddyn roedd *The Concise History of the Society (1751 – 2001)* ar gael i'r cyhoedd trwy'r wefan. Gwneir recordiadau clywedol o'r rhan fwyaf o'r darlithoedd ac mae'r rhain ar gael i'r aelodau fel podlediadau. Yn bennaf trwy hwylustod taliad debyd uniongyrchol GoCardless, mae'r wefan hefyd yn cyflymu proses talu tanysgrifiadau ac felly'n helpu i gynyddu aelodaeth.

## Annog astudiaeth ac ymchwil

#### Y Bwygraffiadur Cymreig

Mae'r Bywgraffiadur Cymreig yn gyhoeddiad cyfeiriadurol hanfodol. Fe'i cyhoeddwyd gan y Gymdeithas yn wreiddiol mewn dwy gyfrol yn yr iaith Saesneg a thair yn yr iaith Gymraeg yn delio â hanes Cymru hyd at 1970. Lansiwyd fersiwn ar-lein gan Lyfrgell Genedlaethol Cymru yn 2007, gan ychwanegu eitemau newydd a diwygio a diweddaru erthyglau gwreiddiol. Mae'r cynnwys cyfan ar gael am ddim ar wefan y Llyfrgell (http://yba.llgc.org.uk/en / http://yba.llgc.org.uk/cy). Yn 2014, cytunodd y Llyfrgell a Chanolfan Uwchefrydiau Cymreig a Cheltaidd Prifysgol Cymru (CAWCS) i weithio mewn partneriaeth i gynnal a datblygu'r Bywgraffiadur ar ran y Cymmrodorion. Yn yr un flwyddyn, cyfrannodd y Gymdeithas £5,000 tuag at gostau'r Bywgraffiadur.

Yn ystod 2015, parhaodd aelodau'r Cyngor i gysylltu'n agos â'r Llyfrgell a'r Ganolfan ynghylch y prosiect. Fodd bynnag, yn dilyn ymddeoliad y Llyfrgellydd a'i ymddiswyddiad wedyn fel Cyd-Olygydd y Bwygraffiadur roedd datblygiad yn ystod y flwyddyn yn arafach na'r gobaith. Penderfynodd y Cyngor i ohirio penderfynu ar p'un ai i roi grant pellach ai peidio i gefnogi'r prosiect nes bod y sefyllfa wedi ei datrys. Yn y cyfamser, bydd yn parhau i gefnogi ymdrechion y Llyfrgell a CAWCS i roi cyhoeddusrwydd i'r prosiect ac i godi arian o ffynonellau allanol. I'r diben hwnnw, mae wedi cytuno y cynhelir darlith ar y Bywgraffiadur yn rhaglen y Gymdeithas yn 2016/17 a bydd yr Athro Dafydd Johnston, Cyfarwyddwr CAWCS, yn siarad ar *The history and future of the Dictionary of Welsh Biography* ym mis Hydref 2016.

#### Y Prosiect Addysg

Yn dilyn penderfyniad cynharach i glustnodi adnoddau i ariannu prosiect ymchwil i ymchwilio i'r ystadegau a ddyfynnir ynghylch sefyllfa presennol addysg yng Nghymru, rhoddodd yr awdur a gomisiynwyd i ysgrifennu adroddiad ar y mater hwn, yr Athro Gareth Rees o Sefydliad Ymchwil Gymdeithasol ac Economaidd, Data a Dulliau Cymru (WISERD), Prifysgol Caerdydd, ddarlith i'r Gymdeithas ym Mai 2015 (*Is there a 'Crisis' in Welsh Education? Statistics and the Politics of Educational Opportunity*) ac hefyd cyfranodd i erthygl ar y pwnc i gyfrol o'r *Trafodion* a gyhoeddwyd yn ystod y flwyddyn. Cafodd yr adroddiad dderbyniad da ac ysgogodd ddadl ar y ffyrdd o wella addysg yng Nghymru. Ystyriwyd yr adroddiad ar y prosiect gan gyfranogwyr o lywodraeth ac addysg mewn seminar a drefnwyd gan Lywodraeth Cynulliad Cymru ym Mawrth 2015.

<sup>Y</sup> gost gyfan i'r Gymdeithas o gefnogi'r prosiect oedd oddeutu £7,000 (cafwyd £3,000 o hyn gan grant o'r elusen, Allia, sy'n cynorthwyo unigolion a sefydliadau sy'n creu lles cymdeithasol). Roedd y penderfyniad i noddi'r ymchwil hwn ar ddarpariaeth a pholisi addysgol a chymdeithasol cyfredol yng Nghymru yn cynrychioli menter arwyddocaol i'r Gymdeithas. Rhoddir ystyriaeth i'r posibilrwydd o gefnogi gwaith ymchwil pellach yn y dyfodol, un ai yn y maes hwn neu faes arall ble byddai cefnogaeth y Gymdeithas yn gwneud gwahaniaeth.

## Gweithio gyda sefydliadau eraill

Mae adeiladu perthynas gyda chynrychiolwyr sefydliadau eraill yn agwedd bwysig o waith y Gymdeithas.

Llwyddwyd i gynnal perthynas wresog â sefydliadau eraill yn Llundain. Cyfeiriwyd eisoes at y darlithoedd a drefnwyd mewn cysylltiad â Chymru yn Llundain a Chymdeithas Sir Drefaldwyn. Parhawyd perthynas dda â Chanolfan Cymry Llundain oedd wedi cytuno'n flaenorol y gellid defnyddio ei safle fel cyfeiriad swyddogol y Gymdeithas - 157-163 Gray's Inn Road, Llundain WC1X8UE. Mae'r Gymdeithas yn parhau i storio rhai o'i chyhoeddiadau a'i dogfennau yn Llyfrgell Sian Busby y Ganolfan.

Hefyd mae'r Gymdeithas wedi parhau i weithio gyda sefydliadau yng Nghymru. Roedd y rhain yn cynnwys yr Eisteddfod Genedlaethol, oedd unwaith eto wedi darparu cyfleusterau ar gyfer Darlith Eisteddfodol flynyddol y Gymdeithas. Fel y nodwyd uchod, mae'r Gymdeithas hefyd wedi parhau i gydweithio â Llyfrgell Genedlaethol Cymru a Chanolfan Uwchefrydiau Cymreig a Cheltaidd Prifysgol Cymru i gefnogi'r Bwygraffiadur Cymreig.

Sefydlwyd cysylltiadau cryfach gyda Chymdeithas Ddysgedig Cymru (CDdC) yn ystod y flwyddyn. Ym mis Tachwedd 2015, rhoddodd y Llywydd (sy'n Gymrawd Sefydlol CDdC) ddarlith ar achlysur y dathliad a gynhaliwyd yng Nghanolfan Mileniwm Cymru ym Mae Caerdydd ar 19 Tachwedd 2015 i nodi cyflwyno Siarter Brenhinol i Gymdeithas Ddysgedig Cymru; ac (eto fel y nodwyd uchod) cynhaliwyd y cyntaf o gyfres o ddarlithoedd ar y cyd sydd wedi eu trefnu gan y Cymmrodorion a'r CDdC yng Nghaerdydd yn Rhagfyr 2015.

## Sut mae gweithgareddau'r Gymdeithas yn cyflwyno budd cyhoeddus

Yn ôl termau'r Ddeddf Elusennau 2011, mae amcanion Anrhydeddus Gymdeithas y Cymmrodorion, fel y'u gosodir yn y Siarter, yn "amcanion elusennol" yn ôl diffiniad y Ddeddf. Maent yn cyflawni'r gofyn hwn trwy (i) fod er budd y cyhoedd a (ii) thrwy gyflawni'r disgrifiad o ddau o'r amcanion a ddiffinir yn Rhan 1, adran 2, is-adran 2 y Ddeddf, sef:

## b) hyrwyddo addysg; a

f) hyrwyddo'r celfyddydau, treftadaeth neu wyddoniaeth.

Ymhlith gweithgareddau'r Gymdeithas sydd o fudd i'r cyhoedd mae'r rhain yn benodol:

- (1) hyrwyddo, cefnogi a hybu astudiaeth ac ymchwil a dosbarthu canlyniadau hyn i'r cyhoedd;
- (2) hwyluso trafodaeth wybodus a rhyngweithredu'r cyhoedd ar ystod o faterion a phynciau, gan alluogi gwelliant yn nealltwriaeth y cyhoedd, ac ym mywyd deallus yn gyffredinol.

Y cyhoedd a "chymdeithas" yn gyffredinol, yn Llundain a Chymru ac yn ehangach, yw'r rhai sy'n elwa o weithgareddau'r Gymdeithas, fel nad yw'r buddion wedi eu cyfyngu gan ddaearyddiaeth. Nid oes unrhyw gyfyngiadau ar angen elusennol.

Rhydd y gweithgareddau fudd i'r cyhoedd mewn nifer o ffyrdd: trwy roi llwyfan tu hwnt i ffiniau Cymru i ystyried materion o bwysigrwydd i Gymru; trwy drefnu rhaglen o ddarlithoedd a thrafodaethau, yn cynnwys darlith yn yr Eisteddfod Genedlaethol, sydd yn agored ac yn rhad ac am ddim i'r cyhoedd; trwy gefnogi ysgolheictod ac ymchwil megis y Bwygraffiadur Cymreig a'r Prosiect Addysg; trwy gyhoeddi a dosbarthu gwybodaeth yn y *Trafodion* (sydd wedi ehangu trwy ddigideiddio'r cylchgrawn a'i roi ar-lein ar wefan Llyfrgell Genedlaethol Cymru), yn ogystal â thrwy wefan y Gymdeithas sydd wedi ei hail-ddatblygu ac mae hyn wedi golygu bod gwybodaeth ar gael i gynulleidfa ehangach; a thrwy gydweithredu â sefydliadau eraill.

## Datganiad Budd Cyhoeddus

Mae aelodau'r Cyngor, sy'n gweithredu yn unol â'u swyddogaeth fel Ymddiriedolwyr, wedi cydymffurfio â'r gofyn hanfodol bod elusennau llai yn adrodd ar Fudd Cyhoeddus, ac yn eu dyletswydd i ystyried canllawiau budd cyhoeddus y comisiwn pan yn defnyddio'r pwerau neu'r dyletswyddau sy'n berthnasol i'r canllawiau.

## **Arolwg Ariannol**

Mae sefyllfa ariannol y Gymdeithas yn iach. Dengys y Cyfrifon Cyllid bod £4,406 dros ben ar gyfer y flwyddyn a bod asedau cyfansymiol y Gymdeithas ar ddiwedd 2015 yn £177,740.

Nid yw'r Gymdeithas yn cyflogi unrhyw staff ac felly nid oes unrhyw gostau yn hyn. Mae hyrwyddo ei gweithgareddau'n ddibynnol ar fewnbwn gwirfoddol aelodau'r Cyngor ac aelodau eraill y Gymdeithas.

Er bod yr incwm o danysgrifiadau 4% yn llai nag yn 2014, roedd yr incwm hwnnw, ynghyd â'r Cymorth Rhodd a gafwyd yn ôl, yn golygu cyfanswm o £22,376 o'i gymharu â'r gwariant blynyddol rheolaidd (hynny yw, gwariant heblaw'r gwariant cyfalaf ar y Prosiect Addysg) o £19,019. Ar hyn o bryd, felly, mae'r Gymdeithas yn "talu ei ffordd" gydag incwm o'r tanysgrifiadau yn ateb y costau blynyddol ac nid oes achos ar hyn o bryd i gynyddu lefel y tanysgrifiadau. Fodd bynnag, mae hyn yn ddibynnol ar y Gymdeithas yn cynnal lefel bresennol ei haelodaeth, ac hefyd bod dim newid anffafriol i drefniadau'r Cymorth Rhodd.

Roedd cyfanswm yr incwm o dansygrifiadau, a'r Cymorth Rhodd a dalwyd yn ôl, yn cyfrif am 74% o holl dderbyniadau'r Gymdeithas yn 2015. Roedd y rhan fwyaf o weddill y derbyniadau (£6,334, neu 21%) yn dod o incwm o'r buddsoddiadau. Mae'r incwm o fuddsoddiadau'n cynrychioli elw o ychydig dros 4% y flwyddyn ar werth y farchnad o'r buddsoddiadau a ddyfynwyd. Mae'r incwm hwn yn darparu cadernid ariannol ychwanegol ac hefyd yn darparu'r adnoddau i ariannu prosiectau ymchwil penodol a gwariant cyfalaf arall.

Gwariodd y Gymdeithas £8,000 yn 2014 ar wefan newydd a £5,000 ar grant tuag at y Bywgraffiadur Cymreig. Yn 2015 gwariodd £7,000 ar brosiect ymchwil ar yr ystadegau a ddyfynwyd ynghylch sefyllfa addysg yng Nghymru. Mae hyn yn cynrychioli cyfanswm net o wariant "cyfalaf" o £17,000 dros y ddwy flynedd ddiwethaf.

## Polisi ar Gadw a Buddsoddi Cronfeydd

Mae'r Gymdeithas wedi cronni cronfeydd dros y blynyddoedd. Crëwyd y cronfeydd hyn am ddau reswm:

- yn gyntaf, i sicrhau, pe bae'r Gymdeithas yn mynd trwy adeg o gynni, yna byddai digon o adnoddau i barhau i weithredu nes bod amgylchiadau gwell yn bodoli;
- yn ail, ac yn bwysig, i ddarparu arian i ariannu prosiectau penodol o natur cyfalaf a oedd yn rhy fawr i'w hariannu gan lefelau incwm arferol y Gymdeithas.

Mae'r Cyngor yn ystyried gwariant dan yr ail gategori yn "wariant cyfalaf".

Mae asedau'r Gymdeithas yn cynnwys arian parod (tua £24,000 ar 31 Rhagfyr 2015) ynghyd â'i buddsoddiadau (tua £154,000).

Nid oes unrhyw gyfyngiadau ar sut y cymhwysir y cronfeydd ac mae'r Cyngor yn ystyried bod ganddo'r grym i gronni incwm i mewn i'r cronfeydd. Fodd bynnag, nid bwriad y Cyngor yw cronni cronfeydd heblaw am y dibenion a amlinellir uchod. Fel arfer nid oes unrhyw fwriad i ychwanegu at fuddsoddiadau'r Gymdeithas na'u realeiddio.

Mae'r Gymdeithas wedi cymeradwyo polisi buddsoddiad a adolygir yn flynyddol (yn Hydref 2015 yn fwyaf diweddar). Yn gyfredol, mae'r buddsoddiadau'n cynnwys unedau mewn cronfeydd i elusennau'n unig, un buddsoddiad mewn soddgyfrannau ac un arall mewn bondiau. Rhennir y cronfeydd, yn gyfartal ar y cyfan, rhwng dau sefydliad buddsoddi blaenllaw, M&G Investments a Schroder. Anrhydeddus Gymdeithas Y Cymmrodorion Sefydlwyd 1751

## Governance

## **Governing Document: the Royal Charter**

The Honourable Society of Cymmrodorion was founded in 1751 and was granted its Royal Charter in 1951. The Charter and Bye-Laws now in force are as amended by Order of the Privy Council dated 21<sup>st</sup> July 1999.

## **Responsibilities of the Council**

The Charter provides for the Council to "have the management and control of the Society and the administration of all the property and income thereof". As such, the Council has responsibility for exercising the powers of the Society in furtherance of its objects. The Society's powers and objects are defined in the Charter. The Society is a Registered Charity (Number 313141) and the members of the Council serve as Charity Trustees for the purpose of charity law. All members of Council give of their time voluntarily and receive no benefits from the charity. The Council is required to meet on no fewer than three occasions each year.

## **Recruitment and Appointment of Members of the Council**

The Society's Charter and Bye-Laws provide for:

- the Council to comprise not less than twelve and not more than thirty Members;
- one third of the Council members to retire in rotation each year;
- members of the Council to be eligible for re-election without restriction;
- vacancies to be filled by election by the Annual General Meeting of the Society;
- the Council to have power to fill vacancies on the Council during the year subject to confirmation at the next Annual General Meeting.

Members may nominate one or more persons from amongst their number for election to the Council by the Annual General Meeting.

The following Council members were elected for a period of three years during the Annual General Meeting in May 2015: Anne Arnold, Elinor Talfan Delaney, Peter Jeffreys, Robert John, Arwyn Lloyd Hughes, Ceridwen Roberts, Rhian Medi Roberts and Lynn Williams. The Council wishes to place on record its appreciation of the service provided by Dr Elizabeth Allen, who decided not to seek reelection to the Council for a further term beyond the Annual General Meeting in 2015.

## **Trustee Induction and Training**

Trustees have been provided with access to the documentation relevant to their responsibilities under the Charities Act and the Council has undertaken to receive an annual update on the role and responsibilities of Charity Trustees. Members of the Council have wide experience of governance and matters relating to the administration of charities and are fully familiar with the objects and aims of the Society and with its work.

## The Annual General Meeting

The business of the Annual General Meeting of members of the Society includes the receipt of the statement of Accounts for the year ended the previous 31st day of December and of associated reports, as well as the election of certain of the Society's Officers and of the members of the Council.

## **Related Parties**

The Society is a fully independent organisation but pursues constructive interaction with representatives of a range of other bodies, notably societies and national and local organisations in Wales and in London.

## **Organisational Structure**

## Officers

## President

The Society's President is a member of the Council, *ex officio*, and is elected each year by the members in the Annual General Meeting. Professor Prys Morgan was re-elected to the office of President on 12 May 2015.

## Vice-Presidents

The Bye-Laws provide for there to be (an unspecified number of) Vice-Presidents who are subject to election or re-election each year by the Annual General Meeting. Twenty-three Vice-Presidents were re-elected at the Annual General Meeting held on 12 May 2015. The office of Vice-President is an honorary office and the Vice-Presidents are not *ex officio* members of the Council.

It was with great sadness that the Society recorded the deaths of five of its Vice-Presidents during 2015: Trefor M Owen MA FSA (ob. 25 February 2015); Emeritus Professor R Geraint Gruffydd DPhil DLitt FLSW FBA (ob. 24 March 2015); the Honourable Emlyn I Griffith (ob. 12 April 2015); His Honour Dewi Watkin Powell MA LLD (ob. 6 May 2015); and the Rt Hon The Lord Howe of Aberavon CH QC PC LLD (ob. 9 October 2015). All had served the Society with great distinction. The President represented the Society at the funerals of Professor Geraint Gruffydd and His Honour Watkin Powell.

## Chair of Council

The Chair of Council is appointed by and from amongst the members of the Council for a period of three years, which is renewable. The Chair of Council throughout the period covered by this Report was Gwenda Sippings.

## Honorary Treasurer

The Honorary Treasurer is appointed by and from amongst the members of the Council for a period of three years, which is renewable. The Honorary Treasurer throughout the period covered by this Report was Huw Wynne-Griffith.

## **Honorary Secretary**

The Honorary Secretary is appointed by and from amongst the members of the Council for a period of three years, which is renewable. The Honorary Secretary for the period 1 January 2015 to the close of the Annual General Meeting held on 12 May 2015 was Peter Jeffreys; the Honorary Secretary for the remainder of the year 2015 was Lynn Williams.

The Council wishes to place on record its appreciation of the considerable contribution that Mr Jeffreys made to the Society during his period of office as Honorary Secretary since October 2009. It wishes, in particular, to acknowledge the fact that he agreed at short notice to take on the role at a difficult time in the Society's development, the importance of his role in helping to modernise the Society and make it more effective, and his estimable work on the organisation of the Society's lecture programme. Mr Jeffreys remains a valued member of the Council.

#### Honorary Editor

The Honorary Editor (who edits the Society's journal, the *Transactions*), is appointed by and from amongst the members of the Council for a period of three years, which is renewable. The Honorary Editor throughout the period covered by this Report was Professor Helen Fulton.

#### Membership Secretary

During the period 1 January 2015 to the close of the meeting of the Council held on 28 October 2015, Adrian Morgan continued to serve as the Membership Secretary. On that date, the Council resolved that this office should be subsumed within that of Honorary Treasurer. The Council wishes to place on record its appreciation of the valuable service provided by the Reverend Dr Morgan during his period of office. The Rev'd Dr Morgan remains a valued member of the Council.

#### Secretary to the Council

Elinor Talfan Delaney continued to serve as the Secretary to the Council during the period 1 January 2015 to the close of the meeting of the Council held on 28 October 2015. On that date, the Council resolved that this office should be subsumed within that of Honorary Secretary. The Council wishes to place on record its appreciation of the valuable service provided by Mrs Delaney during her period of office. Mrs Delaney remains a valued member of the Council.

The Council has the power under the Charter to delegate all or any of its powers to committees or sub-committees and has approved terms of reference for the Executive Committee which prescribe the conditions under which the latter may exercise certain powers of the Council in furtherance of the Society's objects.

## **Charitable Objects**

The Society's 1951 Charter provides as follows:

The Society is hereby incorporated and shall be conducted with the following objects:-

- (A) Subject to any necessary sanction or consent to take over from the Old Society its assets and liabilities and to carry on and develop the work of the Old Society.
- (B) To encourage the study of and research in Literature, History, The Arts and Science in so far as they are of special interest to Welsh people.
- (C) To promote the development of Literature, The Arts and Science in Wales.
- (D) To provide opportunities for scholars to read papers and publish works on Literature, History, Science and The Arts in so far as they are of special interest to Welsh people.
- (E) To provide a common forum for the discussion of matters and movements specially affecting Welsh culture.
- (F) From time to time to sponsor new undertakings advantageous to Wales in scholarship and education.

Further to these objects, the Society exists to promote Literature, History, the Arts and Science (including Social Science) in so far as they are of special interest to Welsh people, and to facilitate discussion in these areas.

## **Activities and Achievements**

In addition to addressing the fundamental tasks of seeking to ensure its financial security and maintaining its governance systems and procedures, during 2015, the Society continued to deliver its objects by focusing on carrying out the following activities:

- arranging an annual programme of lectures and discussions;
- publishing the journal, Transactions, and providing information online
- encouraging study and research;
- working with other organisations.

## **Programme of Lectures and Discussions**

Eleven lectures were held during the course of the calendar year 2015. These included the annual June Gruffydd Memorial Lecture, which was organised in association with the Montgomeryshire Society; the annual Welsh-medium lecture, which was supported by the Welsh Government; and the first in a planned series of annual lectures organised in association with the Learned Society of Wales. All lectures took place in London apart from that which was delivered at the National Eisteddfod (held in Meifod, Powys) and that which was organised jointly with the Learned Society of Wales (which was held in Cardiff University).

The lecture programme provides a platform for issues of importance to Wales to be considered both within the Principality and beyond its boundaries. The Society's lectures are publicised *via* its website and by means of a printed programme which is circulated to members. They are open to the public and attendance is free.

The Council is grateful to those who accepted its invitation to deliver lectures – particularly Lt General Jonathon Riley and Dr Adam Chapman, both of whom stepped in at very short notice – and to those who chaired the meetings. The Council also thanks the staff of the Medical Society of London in whose premises all but one of its London lectures were held and those of the Welsh Government Office in Victoria Street which provided the venue for the annual lecture in Welsh. It is also grateful for assistance provided at the National Eisteddfod in Meifod.

Attendance at lectures was good throughout the year. Contributions to the programme were of high quality and stimulated considerable audience interest, as evidenced by the lively question-and-answer sessions and discussions that followed the lectures.

## **Publications and online information**

The dissemination of information is a key element in the work of the Society. It does this primarily through the publication of its journal, the *Transactions*, and through its recently re-developed website.

## The Society's Transactions

Volume 20 (2014) in the New Series of the *Transactions* was published during the year and a copy was sent to each of the Society's individual and corporate members in the United Kingdom and overseas. The Council thanks all of the contributors and records its appreciation of the work undertaken by the Honorary Editor and the Editorial Board.

The Society seeks, wherever possible, to publish the text of lectures in the journal for the relevant year. This is not always possible – for example, because some speakers do not wish or are not able (because of copyright issues) to publish their papers and because it can sometimes be difficult to translate lectures with a significant visual content into written articles. It was agreed during 2015 that the Editor and the Honorary Secretary should explore ways in which the value to the Society and its members of securing the publication of lectures in the *Transactions* might be impressed upon speakers even more clearly than had previously been the case. This is expected to result in the publication of a higher proportion of lectures in future years.

The Council has agreed that, subject to a two-year embargo on the release of material, and to any restrictions that might be imposed by the right of individual authors to exercise copyright and ownership the entire volume of each issue of the *Transactions* should be made available to the general public in digitised format, through the National Library of Wales portal, *Welsh Journals Online*. (The Council considers that, if open access were to be allowed to current editions there might be little incentive to obtain hard copies through membership of the Society and that this might have a negative impact on recruitment.)

#### **Providing information online**

In line with its commitment to improve communications and to draw the Society's activities to the attention of a wider public, during 2014 the Council had agreed to commission a website wireframe (http://www.cymmrodorion.org/), at a cost of £8,000. Work has been completed and the finished product provides a fresher more modern outlook with a greater capacity to update material. The website is used to advertise Society events and to publicise other activities. The *Concise History of the Society (1751 – 2001)* was made publicly available *via* the site during the year. Audio recordings are made of the majority of lectures and these are made available to members as podcasts. Principally through the facility for GoCardless direct debit payment, the website also speeds up the process for the payment of subscriptions and thereby serves to increase membership.

## **Encouraging study and research**

## The Dictionary of Welsh Biography

The Dictionary of Welsh Biography / Y Bywgraffiadur Cymreig is an essential work of reference. It was originally published by the Society in two English-language and three Welsh-language volumes covering the history of Wales up to 1970. An online version was launched by the National Library of Wales in 2007, with new entries being added and original articles being revised and updated. The entire contents are freely available to the public on the Library's website (http://yba.llgc.org.uk/en / http://yba.llgc.org.uk/cy). In 2014, the Library and the University of Wales Centre for Advanced Welsh and Celtic Studies (CAWCS) agreed to work in partnership to maintain and develop the Dictionary on behalf of the Cymmrodorion. In the same year, the Society made a contribution of £5,000 towards the running costs of the Dictionary.

During 2015, Council members continued to liaise closely with Library and the Centre with regard to the project. However, the retirement of the Librarian and his consequential resignation from the position of Joint Editor of the Dictionary meant that progress during the year was slower than had been hoped. The Council has decided to defer a decision on whether or not to make a further grant to support the project until the situation has been resolved. In the meantime, it will continue to support the efforts of the Library and CAWCS to publicise the project and to raise funds from external sources. To that end, it has agreed that a lecture on the Dictionary should be included in the Society's programme for 2016/17 and Professor Dafydd Johnston, the Director of CAWCS, will speak on *The history and future of the Dictionary of Welsh Biography* in October 2016.

## **The Education Project**

Following an earlier decision to devote resources to funding a research project to enquire into the statistics quoted about the present condition of education in Wales, the author commissioned to write a report on this matter, Professor Gareth Rees of the Wales Institute of Social and Economic Research, Data and Methods (WISERD) at Cardiff University, gave a lecture to the Society in May 2015 (*Is there a 'Crisis' in Welsh Education? Statistics and the Politics of Educational Opportunity*) and also contributed an article on the subject to the edition of the *Transactions* published during the year. The report was well received and stimulated debate on ways of improving education in Wales. Participants from government and from education considered the report on the project during a seminar organised by the Welsh Assembly Government in March 2015.

The total cost to the Society of supporting the project was c. £7,000 (£3,000 of which was met by a grant from the charity, Allia, which supports individuals and organisations that create social benefit). The decision to sponsor this research on current educational and social policy and provision in Wales represented a significant innovation for the Society. Consideration will be given to the possibility of supporting further research work in the future, either in this field or in another area in which its support can make a difference.

## Working with other organisations

The building of relationships with representatives of other organisations is an important aspect of the Society's work.

Cordial relations have been maintained with other organisations in London. Reference has already been made to the lectures organised in association with Wales in London and with the Montgomeryshire Society. Good relations were also maintained with the London Welsh Centre which had previously kindly agreed that its premises might serve as the official address of the Society, 157-163 Gray's Inn Road, London WC1X8UE. The Society continues to store some of its publications and documents in the Centre's Sian Busby Library.

The Society has also continued to work with organisations in Wales. These included the National Eisteddfod, which once again provided facilities for the Society's annual Eisteddfod Lecture. As noted above, the Society also continued to collaborate with the National Library of Wales and the University of Wales Centre for Advanced Welsh and Celtic Studies in support of the Dictionary of Welsh Biography.

Closer links were established with the Learned Society of Wales (LSW) during the year. In November 2015, the President (who is a Founding Fellow of the LSW) gave an address on the occasion of the celebration held in the Wales Millennium Centre in Cardiff Bay on 19 November 2015 to mark the granting of a Royal Charter to the Learned Society of Wales; and (again as noted above), the first in a planned series of joint annual lectures organised by the Cymmrodorion and the LSW was held in Cardiff in December 2015.

## How the Society's activities deliver public benefit

As is required under the terms of the Charities Act 2011, the objects of the Honourable Society of Cymmrodorion, as set out in the Charter, are "charitable purposes" as defined in the Act. They fulfil this requirement in that (i) they are for the public benefit and (ii) they fall in particular within the description of two of the purposes defined in Part 1, section 2, sub-section 2 of the Act, namely:

b) the advancement of education; and

f) the advancement of the arts, culture, heritage or science.

The benefits to the public from the Society's activities include in particular:

- the promotion, support and advancement of study and research and the public dissemination of the outputs thereof;
- (2) the facilitation of informed debate and public interaction on a range of issues and subjects, with consequential improvements in public understanding, and in the health of intellectual life in general.

The beneficiaries of the Society's activities are the public and "society" in general, in London and in Wales, in particular, but also more widely, so that benefits are not restricted by geography. Nor are there any restrictions based on charitable need.

The activities confer public benefit in a number of ways: through the provision of a platform beyond the boundaries of Wales for consideration of issues of importance to Wales; through the organisation of a programme of lectures and discussions, including a lecture at the National

Eisteddfod, that are free and open to the public; through support for scholarly and research activities such as the Dictionary of Welsh Biography and the Education Project; through the publication and dissemination of information in the *Transactions* (which has been enhanced by the digitisation of the journal and its provision on-line *via* the National Library of Wales website), as well as *via* its own re-developed website, which has resulted in information becoming more readily accessible to a wider audience; and through collaboration with other organisations.

## Public Benefit Statement

The members of the Council, acting in their capacity as Trustees of the charity, have complied with the Public Benefit reporting requirement for smaller charities and with their duty to have due regard to the commission's public benefit guidance when exercising any powers or duties to which the guidance is relevant.

## **Financial Review**

The Society's financial position is healthy. The Revenue Accounts show a surplus for the year of  $\pounds$ 4,406 and the total assets of the Society at the end of 2015 stood at  $\pounds$ 177,740.

The Society does not employ any staff and so does not incur any costs in this regard. The promotion of its activities is heavily dependent upon the voluntary input of members of the Council and of other members of the Society.

Although income from subscriptions was 4% less than in 2014, that income, together with the Gift Aid recovered, amounted to £22,376 compared to the annual recurrent spend (that is, spend other than the capital expenditure on the Education Project) of £19,019. At present, therefore, the Society is "paying its way", with subscription income meeting annual costs, and there is no immediate case for an increase in the level of subscriptions. However, this is dependent on the Society's at least maintaining the present level of membership and on there being no adverse change to the Gift Aid arrangements.

Income from subscriptions and recovered Gift Aid amounted to 74% of the Society's total receipts in 2015. Almost all of the remainder of the receipts (£6,334, or 21%) derived from investment income. The income from investments represents a yield of just over 4% a year on the market value of the quoted investments. This income provides additional financial stability and also provides the resources to finance specific research projects and other capital expenditure.

The Society spent £8,000 in 2014 on a new website and £5,000 on a grant to the Dictionary of Welsh Biography. In 2015 it spent £7,000 on a research project into the statistics quoted about the condition of education in Wales. This represents a net total "capital" expenditure over the past two years of £17,000.

## **Policy on Holding and Investing Reserves**

The Society has accumulated reserves over the years. These reserves were created for two reasons:

- first, to ensure that, should hard times befall the Society, then there would be sufficient resources for it to continue to function until more favourable circumstances prevailed;
- secondly, and importantly, to provide funds to finance particular projects of a capital nature that were too large to be absorbed by the Society's normal levels of income.

Spending under the second category is considered by the Council to be "capital spending".

The assets of the Society consist of cash (c. £24,000 as at 31 December 2015) together with its investments (c. £154,000).

There are no restrictions on how the reserves are applied and the Council considers that it has the power to accumulate income into the reserves. However, it is not the intention of the Council to accumulate funds except for the purposes outlined above. There is normally no intention to add to the Society's investments or to realise them.

The Society has approved an investment policy which is reviewed annually (most recently in October 2015). Currently, the investments consist of units in charity-only pooled funds, one invested in equities and another in bonds. The funds are shared, broadly equally, between two leading investment institutions, M&G Investments and Schroder.
