Unconfirmed Minutes of the Annual General Meeting, held at the Medical Society of London, 11 Chandos Street, Cavendish Square, London W1G 9EB, at 6.00 p.m. on Tuesday, 23 May 2017, with twenty-seven members in attendance.

1. In the absence of the President, who was unable to attend because of a family bereavement, members present approved a proposal from the Chair of Council, Ceridwen Roberts, that the Honorary Secretary, Dr Lynn Williams, should chair the meeting.
2. **Apologies for absence** were received from fifteen members.
3. **Minutes of the Annual General meeting held on 4 May 2016**  
These had been circulated and were accepted by the meeting.
4. **The Trustees' Annual Report and Accounts for 2016**  
The Honorary Secretary presented the Annual Report and Accounts, which had been circulated.

Members present noted that:

1. the Trustees' Annual Report included reports on the Society's Governance and Organisation, on its Charitable Objects and on the activities carried out in furtherance of those Objects and, as was required by the Charity Commission also set out how the Society's activities delivered public benefit (which was a key criterion for charitable status) and included a public benefit statement;
2. the Accounts and the associated financial report showed a healthy financial position.

The Trustees' Annual Report and Accounts were accepted by the meeting.

**5. Elections**

**5.1 President**

By unanimous acclaim, Professor Prys Morgan was re-elected President of the Society for the forthcoming year.

**5.2 Vice-Presidents**

The meeting noted:

- .1 with sadness the recent death of one of the Society's Vice-Presidents, Lord Gwilym Prys Davies of Llanegrynn;

.2 that, further to a survey of the wishes of Vice-Presidents held earlier during the year, Mr Geraint Francis Roberts had indicated that he did not wish to be considered for re-election as a Vice-President of the Society in 2017.

The Honorary Secretary reported that the Society's gratitude had been conveyed to Mr Roberts for his service during his term of office as a Vice-President.

The remaining current Vice-Presidents were re-elected to serve in the role for the forthcoming year.

**5.3. *Council Members***

Professor Thomas Charles-Edwards, Professor Stuart Cole, Professor Helen Fulton and Mr Huw Wynne-Griffith were re-elected to serve on the Council for a further three years, 2017-2020.

Further to the invitation issued to members to stand for election to the Council, two completed nomination forms had been submitted by the due date, in the names of Mr Huw Llewelyn Davies and Mr Mathew Kidwell.

Mr Davies and Mr Kidwell were elected to membership of the Council for the three-year period, 2017-2020.

The Honorary Secretary reported, with great regret, that three members of the Council, Professor John Elliott, Mrs Gwenda Sippings (each of whom had served with distinction and for extensive periods as members and as Chairs of Council and its Committees) and Professor Gruffydd Aled Williams (who, as well as serving as a member of Council and its Committees, had also represented the Society on the Advisory Committee for the Dictionary of Welsh Biography), had decided not to stand for re-election to the Council when their terms of office came to an end at the close of the present meeting. The Honorary Secretary thanked them for their important contributions to the work of the Society.

**6. *Independent Examiner***

Professor Richard Lewis of Lewis & Co was appointed as the independent examiner of the accounts for the forthcoming year.

**7. *Thanks***

The Honorary Secretary thanked all those who had by voluntary effort aided the work of the Society during the year, in particular the Officers.
